II. SPEAKERS

- A. Jacques LaRochelle, Public Works Director, Project Mgr. Napa Civic Center Project AND Heather Maloney, Administrative Services Manager for Public Works
 - Why do we need a civic center? Current facilities are over 50-70 years old. **Renting space is costly.** Remodeling spaces is not financially viable.
 - Public Private Partnership: Key benefits of this partnership is guaranteed maximum costs, fixed annual payments, performance criteria, hand-back condition requirements (*projected costs provided in slides*)
 - Designed this project so once the project development fees are complete, revenue will be recovered from the building.
 - Why do it now? We've been advised by economic advisors that interest rates are good at this time, have been studying this since 2009 to find a development partner on-board, this is the most cost-effective and was based on competitive bidding.
 - Schedule: Details on design should be secured in late 2018 or early 2019, followed by 2-year construction period. Occupancy by mid- to late 2021. Would construct public and private spaces simultaneously to maintain condensed timeline. Downtown public safety facilities will be relocated to "swing space" (temporary space). Also considering using the former Health and Human Services facilities as "swing space" for administrative offices.
 - Sustainability: Facility should meet LEED Gold standard
 - Jobs: Public facilities will all be subject to prevailing wages, local business participation employment, prequalification for building trades/contract awards.
 - Affordable Housing: Private development piece must hold minimum number of units equivalent to 10% of the market rate units. Community Information: There have been several community and government meetings since 2009. People can attend the Community Open House on July 18, 2018 at the Senior Center for more questions.


