I have gained a broad perspective of Napa County and the surrounding region. I believe local government is responsible for advocating and leading on issues, and this has guided my work in navigating complex issues. I am well prepared to contribute to a bright and forward-thinking future for our community.

- 4. What distinguishes your candidacy and campaign from the other candidates for this office? My leadership abilities, and continued dedication and determination to serve the Town of Yountville as exemplified by my service as Yountville's representative on the Napa Valley Transportation Authority Citizen Advisory Committee, as a Member of the Board of the Town of Yountville Community Foundation, and seven years serving the Town of Yountville as Library Commissioner, as well as my candidacy for a Member of the Town Council in the 2020 election distinguishes me from my fellow candidates.

- 5. What do you see as the major issues and their possible solutions in this campaign? Two of the major issues for Yountville, among many others, are water conservation and commercial and residential development.
 - 1) Natural resources management and conservation for Yountville's water supply during a water shortage emergency is a major issue. Members of the Town Council along with Town Staff must manage the purchase, distribution, and rate collection, and empower residents with the tools to manage and monitor their water consumption as we collectively consume and conserve this vital resource.
 - 2) Residential and commercial development: upcoming commercial development of large, central parcels to ensure thoughtful development, which includes assets to engage visitors and residents, and strengthen Yountville's strong transient oriented tax base while focusing on transit-oriented development. Equally important is encouraging thoughtful development of new, affordable housing and working with developers to implement the regional housing needs assessment commitment (RHNA) identified by Youtnville's Zoning and Design Review Board and the Town Council. As a member of the Town Council, I would the strive to achieve balance both with and for residents and the business community.
